The request of the petitioner for alternative accommodation will be considered by the 3rd respondent positively and a suitable alternate site with basic amenities for conducting business will be provided by the 3rd respondent. Only thereafter, the petitioners have to vacate from the present complex.

3. The writ petition is disposed of by recording the said submission made by the learned Government Advocate (Pondicherry) for the respondents 1 to 4. No costs. Consequently, the connected miscellaneous petition is closed.
