PRAYER: Original Petition filed for Succession Certificate under Section 372 of Indian Succession Act, 1925 under Order XXV Rule 6 of Original Side Rules, prays that a Succession Certificate may be granted in favour of the Petitioners with powers to receive the interest and dividends on and negotiate and transfer the securities as specified in the schedule annexed hereto.

ORDER

The petitioners seek Succession Certificate in respect of the securities held by Dr.M.S.Vatsala, who died intestate on 19.07.2010. The petitioners are the daughters of the deceased Dr.M.S.Vatsala.

2. The second petitioner has been examined as P.W.1. She has produced the death certificates of the deceased Dr.M.S.Vatsala and T.M. Nachinarkinian (father of the petitioners), as Exs.P2 and P1, and the legal heirship certificate of the deceased T.M. Nachinarkinian as Ex.P3. A perusal of Ex.P3 shows that the

petitioners are the only legal heirs of T.M. Nachinarkinian and Dr.M.S.Vatsala.

A paper publication has been made and any objections have not been received.

3. In view of the above said evidence, the Original Petition is allowed by granting Succession Certificate in favour of the petitioners, in respect of the securities mentioned in the schedule to the petition.
