This Criminal Original Petition has been filed seeking to direct the Principal District and Sessions Judge (Special Court for Trial of Cases under the SC/ST (POA) Act), Tiruvannamalai to accept the surrender of the petitioner in connection with Crime No. 347 of 2022 on the file of the second respondent and to consider and pass orders in the bail application on the same day.

2. In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. The petitioner is directed to surrender before the Trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned Special Judge shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.
