PRAYER: Original Petition filed for Succession Certificate under Section 372 of Indian Succession Act, 1925 under Order XXV Rule 6 of Original Side Rules, prays that a Succession Certificate may be granted in favour of the Petitioner with powers to collect the securities and to receive the interest and dividends on and negotiate and transfer the securities as specified in the schedule annexed hereto.

ORDER

The petitioner seeks Succession Certificate in respect of the securities held by Radha Sundararajan, who died intestate on 14.05.2021. The petitioner is the only son of the deceased Radha Sundararajan.

2. The petitioner has been examined as P.W.1. He has produced the death certificates of the deceased Radha Sundararajan and M.S.Sundararajan (father of the petitioner), as Exs.P1 and P2. The legal heirship certificates of the deceased Radha Sundararajan and

M.S.Sundararajan as Exs.P4 and P3. A perusal of Exs.P3 and P4 shows that the petitioner is the only surviving legal heir of the deceased Radha Sundararajan and M.S.Sundararajan. It is to be noted that the petitioner herein, who is the son of the deceased had also filed an O.P.No.544 of 2022 seeking to issue succession certificate for the securities held by his father late. M.S.Sundararajan. A paper publication has been made and any objections have not been received.

3. In view of the above said evidence, the Original Petition is allowed by granting Succession Certificate in favour of the petitioner in respect of the securities mentioned in the schedule to the petition.
