ORDER

This Writ Petition has been filed to direct the 2nd respondent to consider the representation of the petitioner, dated 07.06.2023.

2.The contention of the petitioners is that the petitioners' father was working as Conductor in the 4th respondent Corporation and retired from service on 30.04.2015 and thereafter, he died on 16.05.2018 leaving behind the petitioners as his legal heirs. After the retirement, the petitioners' father was not paid with the terminal benefits such as provident fund and pension arrears. In this regard, the petitioners have given representation, dated 07.06.2023 to the respondents 2 and 4 along with the death certificate of his father and other relevant documents to release the terminal benefits, however, no order has been passed till date. Hence, seeks direction of this Court.
