The learned Government Advocate (CrI.side) filed a status report stating that pursuant to the order passed by the learned Principal Sessions Judge, Salem, the 2nd, 3rd and 4th accused are signing, however, the 1st accused/petitioner herein has not signed nor appeared before the respondent police and cooperated for the investigation.

4. The present petition is for modification of the condition by stating that petitioner is practising as an advocate before the Salem District.

5. Hence, liberty is granted to the petitioner to appear before the learned Principal Sessions Judge, Salem and to explain his inconvenience and
