**ORDER**

This writ petition has been filed to direct the respondents to consider the representation of the petitioner dated 01.09.2022 and cancel the construction plan issued vide No.PPA/WDCN14/00977/2019 and Construction Sanction No.BA/WDCN14/00947/2019 dated 13.03.2019 issued by the respondents 1<sup>st</sup> and 2<sup>nd</sup> and restrict them from constructing the building in door No.8, Velacherry main road, Pallikaranai village, Sholinganallur Taluk, Kanchipuram District comprised in Survey No.311/2 measuring an extent of 746 sq.ft which belongs to the petitioner.

2. It is the contention of the petitioner to restrict the respondents from constructing the building in Survey No.311/2 measuring an extent of 746 sq.ft which belongs to the petitioner. Therefore, the petitioner gave a representation dated 01.09.2022, which has not been considered.

3. In such view of the matter, as the limited prayer is sought for by the petitioner, petitioner is directed to give a fresh representation within 10 days from the date of receipt of a copy of this order. On such representation
