4.The learned counsel appearing for the respondents on instructions, submits that based on the directions issued by the 2nd respondent, the 4th respondent is in the process of conducting enquiry and final report need to be filed before the 2nd respondent.

5.In view of the above submission made by the learned counsel appearing for the respondents, the 4th respondent is directed to complete the enquiry and file his final report before the 2nd respondent within a period of four (4) weeks from the date of receipt of copy of this order. The 2nd respondent shall forward the report to the 1st respondent with his comments within a period of four (4) weeks thereafter. The 1st respondent shall pass final orders based on the report filed by the 4th respondent within a period of four

(4) weeks from the date of receipt of final report from the 2nd respondent.
