ORDER

The dispute between the family members ended in formation of final report for the Judicial Magistrate-I at Panruti. He took cognizance of the offence against the petitioners 1 to 4 herein. To quash C.C.No.51 of 2023 filed against them before the Judicial Magistrate- I at Panruti a petition under Section 482 of Cr.P.C was filed before this Court and when the matter came up for consideration this matter was referred to mediation.
