PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, to call for the records pertaining to the Auction Notice (hand-bill) bearing No. Nil dated 21.08.2023 on the file of the 2nd respondent, quash the same in so far as the sale relates to lands in S.No.190/3 Thirumalvadi Village, Palacode Taluk, Dharmapuri District, measuring 1.57.5 Hectares (3.89 Acres) and to direct the respondents 1 to 2, to allow the petitioner herein to continue the lease granted vide the Permanent Lease Agreement dated 30.07.1996 (between

the family members of the Petitioner and the erstwhile Trustee of the Arulmighu Perumal Thirukoil) and in pursuant to pending suit in O.S.No.41 of 2019 (on the file of the Learned District Munsif, Palacode) and in pursuant to the pending Record of Tenancy proceedings initiated vide the Petition dated 01.11.2022 on the file of the 3rd respondent, under the Tamilnadu Agricultural Lands Record of Tenancy Act.
