## ORDER

Heard Ms. Gowri. N, Learned Counsel for the Petitioner and Mr.K.Karthikeyan, Learned Government Advocate appearing for the Respondents, and perused the materials placed on record, apart from the pleadings of the parties.

2. According to the Petitioner, it had made a representation dated 19.04.2023 to the First Respondent to bring the Krishnapurumal Bajanai Madam under the control of the Hindu Religious and Charitable Endowments Department of the Government of Tamil Nadu, but as it did not evoke any response, this Writ Petition had been filed.

3. Learned Government Advocate appearing for the Respondents, on instructions, states that the Third Respondent by Proceedings in Order Naa. Ka. No. 2727/2023/A8 dated 04.11.2023 has disposed the said representation and its copy has been produced and Learned Counsel for the Petitioner also acknowledges its receipt in court today.
