Thereafter, the respondent filed HMOP No.2873 of 2023 on the file of the Learned V Additional Family Judge, Chennai, making false allegations against this petitioner. He further submitted that the petitioner is residing at Madurantakam Taluk, Chengalpattu with her aged parents and it is very difficult for the petitioner to attend the court hearings at Tambaram. Hence, he prays to transfer the HMOP No.2873 of 2023 from the file of the Learned V Additional Family Judge, Chennai to the Hon'ble Subordinate Court at Madurantakam.

3. The learned counsel for the respondent has not entered appearance in the present case.

4. Considering the facts and circumstances of the case and also the fact that the petitioner, the reasons stated by the petitioner and the same is justifiable.
