ORDER

2. Heard the learned Counsel for the petitioners and the learned Additional Public Prosecutor for the first respondent.

3. The learned Additional Public Prosecutor submitted that there is a case and counter in Crime No.96 of 2023 and Crime No.97 of 2023.

The contentions put forward by the learned Counsel appearing on behalf of the petitioners are purely factual in nature and this Court cannot venture into conducting a mini investigation into the matter and it therefore does not fall within the ambit of its jurisdiction under Section 482 of Cr.P.C. Any finding on facts will also have a bearing on the investigation conducted by the respondent Police.
