WEB COPY The writ petition has been filed to issue a writ of mandamus directing the 1st respondent to consider the petitioner's representation dated 14.07.2023 and pass orders.

2. The learned counsel appearing for the petitioner would submit that the petitioner was issued Darakastu patta thirty years ago. From then, she is in possession and enjoyment of the property and she is paying the taxes regularly. The Government was asked to issue patta to the land which is enjoyed by the petitioner. He further submitted that due to bifurcation of the District, it was reclassified as banned for registration.

3. The learned Additional Government Pleader appearing for the respondents would submit that due to bifurcation of District, they lost the document and they are not considering the petitioner's representation and prayed to issue a positive order in this writ petition.
