Considering the fact that there is further alienation of the property, it is expected that the concerned respondents will issue notice not only to the persons, who have obtained the planning permission, but also to the subsequent alienees. We expect that the entire exercise shall be completed by the concerned respondents within a period of three months from the date of receipt of a copy of this judgment after hearing all the parties, including the petitioner. Until such time, the Official respondents are refrained from initiating any coercive measures against persons, who are alleged to have encroached the property.

4. With the above order, this Contempt Petition is closed. No costs.
