This petition has been filed challenging one of the condition imposed by the Court below while allowing the application filed by the petitioner for return of vehicle in C.M.P.No.40275 of 2022, dated 21.11.2022.

2. Heard Mr.A.Sathish Kumar, learned Counsel for the petitioner and Mr.A.Gopinath, learned Government Advocate (Crl. Side) for the respondent.

3. The respondent Police seized the vehicle belonging to the petitioner in the course of investigation in Crime No.905 of 2022. The petitioner filed an application for return of vehicle. This application was allowed by an order, dated 22.11.2022. The petitioner is aggrieved by the following condition that was imposed by the Court below:-
