ORDER

This petition has been filed seeking a direction, to direct the Special Judge for exclusive Trial of Cases under SC/ST (POA) Act, Perambalur to consider the bail petition upon his surrender concerned in Crime No.180/2023 on the file of Sub Inspector of Police, Maruvathur Police Station, Perambalur District on the same day.

2.In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioner is directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned Special Judge for exclusive Trial of Cases under SC/ST (POA) Act, Perambalur shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.
