The learned Additional Public Prosecutor, on instructions, submitted that the Deputy Commissioner of Police, Washermenpet District had already transferred the complaint to the file of the Central Crime Branch (Job Racketing team). It is seen that after the above proceedings, there has been absolutely no improvement and the file has not reached the CCB.
