2.The learned counsel for the petitioner submits that he submitted an application for layout approval in respect of the above said land on 10.03.2023 and the same has not been considered by the 2nd respondent.

3.Mrs.S.Anitha, learned Special Government Pleader takes notice for the respondents on instructions, submit that the application of the petitioner will be considered on merits and in accordance with law in due course.
