Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Certiorarified Mandamus, calling for the records relating to the impugned order passed by the 1st respondent in his proceedings Pa.Mu. B1/ 6521/2016, dated 22.11.2016 and quash the same and consequently direct the 1st respondent to measure the land situated in S.No.343/5 to the extent of 0.07 acres and 0.98 acres in S.No.344 and S.No.343 to the extent of 0.89 acres and in S.No.348 to the extent of 0.35 acres at Marimanikuppam Revenue Village & Post, Vaniyambadi Taluk,

ORDER

The order impugned dated 22.11.2016 reveals that the grievance of the writ petitioner cannot be redressed by approaching the Tahsildar. Accordingly, the Tahsildar, Vaniyambadi Taluk has stated that the petitioner is at liberty to approach the Competent Court of Law for redressal of his grievances.

2. This Court is of the considered opinion that the petitioner seeks relief in respect of immovable property belongs to him, such disputes cannot be adjudicated in a writ proceeding and the High Court cannot conduct a roving enquiry in respect of the civil disputes.

3. However, the reasons stated in the impugned order are in consonance with the principles established. Thus, the petitioner is at liberty to approach the Competent Forum for the purpose of redressal of his grievances.

4. With this liberty, this Writ Petition stands disposed of. No costs. Consequently, connected Miscellaneous Petitions are closed.
