4.Learned counsel for the respondents 2, 4 and 5 made a statement on instruction that the property where the petitioner has his residence is a poromboke property and the disconnection has been effected in the course of an execution proceedings in E.P.No.5 of 2015 in O.S.No.43 of 2008 on the file of the learned District Munsif cum Judicial Magistrate, Arcot. The said statement of the learned counsel is recorded.

5.In view of the same, there is nothing left to be considered in this case and the petitioner is required to seek appropriate remedy before appropriate forum.
