Heard Mr.L.Rajendran, learned counsel for the petitioner and Mr.P.Muthukumar, learned State Government Pleader assisted by Mr.K.M.D.Muhilan, learned Additional Government Pleader for respondents 1 to 4.

2. The petitioner is assailing the pattas granted in favour of respondents 5 and 6.

3. Learned State Government Pleader submits that if a person is aggrieved against grant of patta, an alternate remedy is provided under Section 12 of the Tamil Nadu Patta Passbook Act, 1983.

4. In the light of that, if the petitioner is aggrieved, then the petitioner can avail the alternate remedy available under Section 12 of the Tamil Nadu Patta Passbook Act, 1983, as may be permissible under law.
