PRAYER: The writ petition filed under Article 226 of the Constitution of India, for issuance of a writ of Mandamus, forbearing the respondent and their men, agents from collecting current consumption charges, demand charges and any arrears from the petitioner's captive Consumer Current Consumption Bills in HTSC No.079094620183 till the entire outstanding dues of Rs.10,00,000/- payable to the petitioner along with interest towards refundable security deposit in the account of the petitioner's Solar Power Plant HTSC No.489 is paid or give adjustment in the current consumption charges payable by the petitioner till the entire amount is adjusted.
