This case is taken up for settlement before the Lok Adalat. Both the parties are present. Mr.K.Kuppusamy, learned counsel for the Appellant and Mrs.S.Sree Vidhya, learned counsel for the second respondent are present. After mutual discussion, negotiation, mediation and conciliation between both parties, they arrived at a compromise to settle the matter as follows:

**TERMS OF SETTLEMENT**

The Tribunal has awarded a sum of Rs.1,61,404/-, with interest at 7.5% per annum, from the date of petition, till the date of deposit. Aggrieved by the award of the Tribunal, the appellant / claimant had preferred the present appeal.

2. After due deliberation and consultation, both the parties have agreed to enhance the award of the Tribunal by a sum of Rs.75,000/- (Rupees Seventy Five Thousand Only) in full quit, over and above the compensation already awarded.

3. The Second Respondent / Insurance Company is directed to deposit the said sum of Rs.75,000/- in full quit, within a period of four weeks from the date of receipt of a copy of this order, to the credit of M.C.O.P.No.206 of 2009 on the file of Motor Accident Claims Tribunal, I Additional Subordinate Judge, Salem. On such deposit being made, the appellant / claimant is permitted to withdraw the amount on filing proper applications.

4. The Tribunal is directed to transfer the above said award amount to the Bank account of the appellant / claimant by way of NEFT / RTGS, on proper identification, in accordance with the terms of the award, without insisting on any formal permission petition.

5. The Civil Miscellaneous Appeal is disposed of accordingly.
