When the said W.M.P was taken up for hearing on 16.10.2023, this Court ordered notice to the proposed respondents through Court and privately returnable by 08.11.2023 and this Court also directed the learned counsel for the petitioner to file an Affidavit of Service on or before 08.11.2023 and the matter was directed to be listed on 09.11.2023. Today (09.11.2023), when the matter is taken up for hearing, there was no representation for the
