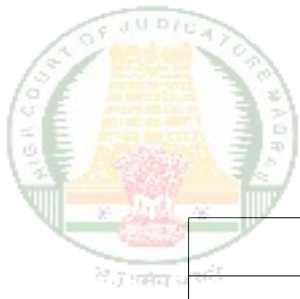

This application is filed by the petitioner in W.P. No.23501 of 2023 for amending the prayer post disposal of the case.

2. The learned counsel submitted that due to inadvertence the prayer column is not made complete in the writ petition and it has now created certain difficulty in working out the order. He explained how what is omitted to be stated. The details are as below:

<i>Original Prayer</i>	<i>Prayer now sought to be amended</i>
"Writ of Mandamus, directing the 1st to 3rd respondent to effect name transfer of WEG Wind Fan No.079224723164 from M/s.Kubitz Infratech (P) Ltd to the name of the petitioner M/s.Bhairavi Green Energy as per the petitioner's application dated 12.06.2023 on payment of necessary charges and pass such further or other orders as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case and thus render justice."	"For the reasons stated above, it is prayed that this Hon'ble Court may be pleased to issue a writ of mandamus, directing the 2nd and 3rd respondent to effect name transfer of Wind Fan No.079224723164 from M/s.Kubitz Infratech (P) Ltd to the name of the petitioner i.e., M/s.Bhairavi Green Energy <u>along with utility charge from sale to board to group captive scheme as per the petitioner's application dated 12.06.2023</u> and pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstances

<i>Original Prayer</i>	<i>Prayer now sought to be amended</i>
	of the case and thus render justice.

3. Heard the learned counsel for the respondent and perused the order.

4. In its order dated 09.08.2023, this court has merely directed the 2nd respondent to consider the representation of the petitioner. However, in recording the prayer in the cause title of the order, the underscored expressions as indicated in column2 is missing and the authority is reluctant to consider the same.

5. Amendment sought is cosmetic. Since this court has not decided anything on the merit of the representation in its order and has relegated the same for the authority to consider, hence no damage would be done to the rights of any of the parties herein.

6. Accordingly the prayer column in the cause title of the order is changed in terms of what is provided in column 2 above.
