The grievance of the petitioners is that their brother, the 4th respondent had obtained a legal heir certificate, excluding the petitioners and his mother. Now, there are two legal heir certificates issued by the same official for the same person. Hence, the petitioners have preferred a representation, dated 22.08.2022 to the 1st respondent to cancel the legal heir certificate granted to the 4th respondent.
