The claim of the Petitioner in the Writ Petition is that he is entitled to continue in office till the expiry of three years from 01.02.2021 when he was elected to the Board of Directors of Soriankuppam Co-operative Milk Producers Union. However, as the Petitioner has not produced relevant documents to substantiate the same, Learned Counsel for the Petitioner seeks permission of this Court to withdraw the Writ Petition with liberty to file a fresh Writ Petition with all relevant documents and he has made an endorsement to that effect in the court record.

In fine, the Writ Petition is dismissed as withdrawn granting such liberty. Consequently, connected Miscellaneous Petition is closed. No costs.
