4. Learned Prosecutor submits that the mother has in fact been informed and aforementioned lapse is an inadvertent omission.

5. As it is a preventive detention case, we remind ourselves that preventive detention is not punishment and HCP is a high prerogative writ. In this view of the matter, we are unable to accept the explanation of learned Prosecutor. The legal reason is, this has hampered the rights of the detenu to make an effective representation against the impugned detention order which is a constitutional safeguard ingrained in Article 22(5) of Constitution of India. Therefore, we find it appropriate to interfere with the impugned detention order.

6. Apropos, the sequitur is, captioned HCP is allowed. Impugned detention order dated 29.06.2022 bearing reference C.M.P.No.65/Goonda/Salem City/2022 made by the second respondent is set aside and the detenu Mr.Pradap @ Sukesh, son of Mr.Manikandan is directed to be set at liberty forthwith, if not required in connection with any
