Heard Mr.S.Senthilnathan, learned counsel for the petitioner and Mr.P.Muthukumar, learned State Government Pleader for the respondents 1 and 2.

Under communication dated 16.06.2023, it appears that the Tahsildar, Perur had informed the Collector, Coimbatore about the encroachment in S.Nos.386/2, 286/2, 238, 226/1, 229, 232, 236 and other lands. Even the names of the encroachers were given. It was further stated that notices under Sections 6 and 7 of the Tamil Nadu

Land Encroachment Act, 1905 were also issued. Survey of the encroached lands was conducted in the presence of the encroachers and stones were laid.

3. According to the petitioner, still the encroachment exists.

5. In view of the said statement, the writ petition is disposed of. There will be no order as to costs.
