ORDER

(Made by the Hon'ble Chief Justice)

Heard Mr.D.Ashok Kumar, learned counsel for the petitioner, Mr.P.Muthukumar, learned State Government Pleader assisted by Mrs.R.Anitha, learned Special Government Pleader for respondents 1 to 5 and Mr.M.Raja Sekhar, learned counsel for respondent 7.

2. The contention is that a cart-track exists, however, the same may be made as a tar road.

3. Learned counsel for the seventh respondent supports the request made by the petitioner and submits that the seventh respondent would also contribute if the Government lays a tar road.

4. The State Authorities may consider the said aspect. Representation is already given on 23.08.2023 to that effect. Appropriate Authorities shall consider the said representation and take a decision, in accordance with law, preferably within a period of four months.
