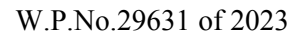

**ORDER**

The petitioner seeks for a mandamus directing the second respondent to sub-divide the Survey No.339/2A2 to an extent of 1075 sq.ft out of total extent of 6.80 acre, situated at Old Ward No.8, New Ward No.11, Karimangalam Village and Taluk, Dharmapuri District and to transfer the Patta in the name of the petitioner based on his application dated 13.12.2022.

The learned counsel for the petitioner submitted that though the petitioner has submitted an on-line application as early as on 13.12.2022 to the second respondent for sub-division and transfer of patta in his name with respect to the subject property, the second respondent has not considered the same yet. Hence, the petitioner is before this Court.
