Thus, mandamus is issued to R1 to issue notice to the petitioner calling for particulars, hear her after furnishing of particulars and pass an order thereafter on the representation of the petitioner on merits and in accordance with law, all within a period of six (6) weeks from date of receipt of a copy of this order.
