ORDER

2. Heard the learned counsel for the petitioner and the learned Additional Government Pleader for the respondents and perused the records.

The respondents 2 and 3 are directed to consider the petitioner's representation, after verifying the old records and giving opportunity to the rival claimants if any, and dispose of the representation in accordance with law, within a period of three months from the date of receipt of copy of this order.

4. With the above directions, the writ petition is disposed of at the admission stage itself. However, there shall be no order as to costs.
