2. The learned counsel appearing on behalf of the petitioner-Company states that when providing Herbal Hookah to the customers of the petitioner-Restaurant is being legally permitted, the respondent-police should not harass the petitioner-Restaurant and its staff members.

3. From the above facts, this Court is of the view that whether



the materials served by the petitioner-Restaurant is permissible under law or not, it is always subject to test and verification. Therefore, a blanket order of protecting the petitioner-Restaurant and its staff members, cannot be granted.

4. In this view of the matter, the present Criminal Original Petition stands dismissed.
