(Delivered by the Hon'ble Chief Justice)

Heard Mr.P.S.Raman, learned Senior Counsel appearing for Mr.D.R.Arun Kumar, learned counsel for the appellants. None appears for the respondent.

2. It is submitted by learned Senior Counsel for the appellants that installments for payment of current consumption charges could not have been granted. The circular relied by the learned Single Judge is not applicable. Learned Senior Counsel further refers to the judgment of the Division Bench of this Court in the case of *The Superintending Engineer, Tamil Nadu Electricity Board and Anr. vs. M/s.Krishna Alloys*¹.
