2.Today, when the matter is taken up for hearing, the learned counsel appearing for the petitioner submitted that it would suffice if a direction is issued to the respondents 1 and 2 to consider the representation of the petitioner dated 02.11.2022.

3.Mr.Yogesh Kannadasan, learned Special Government Pleader, who accepts notice for the respondents 1 and 2 submitted that the respondents may be directed to consider the petitioner's representation dated 02.11.2022 and pass orders in accordance with law.

4. Having regard to the submissions made by the learned counsel on either side, taking into consideration the limited prayer sought for by the petitioner, without expressing any opinion with regard to the merits of the case, this Court directs the respondents 1 and 2 to consider the representation of the petitioner dated 02.11.2022 after conducting enquiry and pass orders in accordance with law, after issuing notice to all the interested parties, as expeditiously as possible, preferably within a period of three months from the date of receipt of a copy of this order.
