## **ORDER**

Writ Petition is filed seeking direction to the respondents to correct or rectify the missing document No.5553 of 2012 instead of Document No.2141/1991 in the Non traceable Certificate dated 08.08.2021 issued by the 2<sup>nd</sup> respondent by considering the petitioner's representation dated 17.08.2023.

This Court is of the view that, petition itself is not maintainable since the application for issuing Non-Traceable Certificate for a particular document bearing Reg.No.2141 of 1991 been considered and certificate was also issued. If petitioner wants Non-Traceable Certificate for different document, he has to file a fresh petition and on such filing of the petition, respondent police will conduct proper enquiry and they will issue Non-Traceable Certificate, if really documents in existence got lost.

3. Accordingly, this Writ Petition is dismissed.
