ORDER

WEB COPY Heard Mr. D.Soundar Raj, Learned Counsel for the Petitioner and Mr. M.Vinoth, Learned Counsel appearing for the Respondent and perused the materials placed on record, apart from the pleadings of the parties.

2. The grievance ventilated by the Petitioner is that he has remitted the entire dues payable to the Respondent for the loan that had been availed by one J.Ravi, Helper, State Express Transport Corporation, for which he had stood as surety, but the Respondent has neither issued the 'No Dues Certificate' as sought by him nor furnished any detailed statement of accounts showing the remaining amount due under that loan till date, which has necessitated the filing of this Writ Petition.

3. Since the Respondent has furnished a copy of the statement of accoutns showing the calculation for the remaining amount due under the said loan, Learned Counsel for the Petitioner seeks permission of the Court to withdraw the Writ Petition reserving the right of the Petitioner to work out his remedies before proper forum in the manner recognized by law and he has made an endorsement to that effect in the court record.
