ORDER

This petition has been filed alleging non-compliance of the order of this Court dated 27.09.2022 passed in W.P.No.25970 of 2022.

2. Learned Government Advocate appearing for the first respondent has placed an order dated 11.01.2023 passed by the first respondent, in compliance of the order dated 27.09.2022 passed by this Court in W.P.No.25970 of 2022. Since the order of this Court has been duly complied with by the first respondent, nothing survives for further adjudication in this petition.

3. However, learned counsel for the petitioner would submit that despite a direction having been given by this Court that the respondents till passing the final orders, will have to pay salary to the petitioner, the same has not been paid by the respondents. At the same time, writ appeal in W.A.No.145 of 2023 has been filed against the order of this Court dated 27.09.2022 passed in W.P.No.25970 of 2022 and the same is pending before the Division Bench of this Court.
