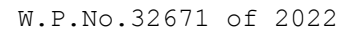

The petitioners have come out with the present Writ Petition for a direction to the 1st respondent to consider their common representation dated 16.11.2022 and pass orders.

3.Mr.E.Vijay Anand, learned Additional Government Pleader appearing for the 1st respondent submitted that the Special Officer, Kaniyam Poondi Village Panchayat has forwarded the proposal dated 18.01.2019 to the 1st respondent and the same will be considered on merits and the 1st respondent will pass orders on merits.

4.Heard the learned counsel appearing for the petitioners as well as the learned Additional Government Pleader appearing for 1st respondent and perused the entire materials on record.

5.From the above submissions and documents filed by the petitioners in the typed set of papers, it is seen that the Kaniyam Poondi Village Panchayat has addressed a letter bearing Na.Ka.No.1380/17/A2, dated 18.01.2019 to the 1st respondent enclosing the documents stating that the land in question has approach road and it is not near any cremation ground, railway track and it is fit for housing site and requested the 1st respondent for further proceedings. In view of the above letter, the 1st respondent is directed to consider the representation of the petitioners dated 16.11.2022 taking into consideration the letter of the

Kaniyam Poondi Village Panchayat dated 18.01.2019, after giving opportunity to the petitioners as well as respondents 2 to 4 and pass orders on merits and in accordance with law. Till such time, the 1st respondent is restrained from taking any coercive steps against the petitioners.
