Having regard to the limited scope of the prayer that is now sought for by the learned counsel for the petitioner, without expressing any opinion on the merits of the petitioner's representation and the case pleaded in this writ petition, the 1st respondent is directed to consider the representation of the petitioner dated 26.10.2023, on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order
