ORDER

Mr.V.Veluchamy, learned Additional Government Pleader accepts notice for respondents. By consent of both sides, main writ petition is taken up for final disposal at the admission stage itself.

2. This writ petition has been filed seeking for a mandamus to direct the 2nd respondent to consider his representation dated 16.08.2023 and online application dated 19.08.2023, wherein and whereby, he sought for separate patta in his favour in respect of the land situated in Survey No.2/2 measuring to an extent of about 54 cents in Kalparapatti Village, Salem Taluk, Salem District.

3. The main grievance of the writ petitioner is that even though the petitioner made the representation on 16.08.2023, the same has not been considered by the respondents so far.

4. Learned counsel for the writ petitioner submits that it would suffice if a direction is given to the respondents to consider the representation dated 16.08.2023.

Such exercise shall be done by the respondents within a period of two months from the date of receipt of a copy of this order. There shall be no order as to costs.
