PRAYER: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus calling for the records of the 1st respondent Bank in issuing the Show Cause Notice dated 16.09.2022 and consequential action classifying the Petitioner as willful defaulter and thereby quash the same and consequently direct the respondent to remove the petitioner from the list of willful defaulters from all forms, on public and private forum and records.

The prayer in the present Writ Petition challenges a proposal by the Willful Default Review Committee of the Indian Bank/R1 dated 16.09.2022 proposing to treat the petitioners as wilful defaulters.

2. The Writ Petition has been filed on 01.11.2023. The very next day, i.e., on 02.11.2023, an order has come to be passed by R1 holding the petitioners as wilful defaulters, which is yet to be challenged by way of a separate Writ Petition.

3. Hence, the petitioner seeks permission to withdraw this Writ Petition with liberty to challenge the said order. He has also made an endorsement to that effect.

4. In light of endorsement made, this Writ Petition is dismissed as withdrawn granting liberty to the petitioner to challenge order dated 02.11.2023 in a manner known to law. Connected Miscellaneous petitions are closed.
