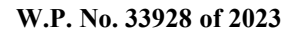
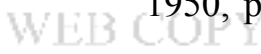

2. The Writ Petition challenges the Proceedings in Pa. Mu. 2379/2023/A2

dated 11.10.2023 passed by the Second Respondent.

3. It is brought to notice by Learned Government Advocate appearing for the First and Second Respondents that after the filing of the Writ Petition, the Petitioner has preferred appeal dated 18.12.2023 against the same order before the First Respondent invoking Section 15 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 and a copy of Notice No. Na. Ka. 16185/ 2023/3/C4 dated 19.12.2023 sent to the Petitioner and the Seventh Respondents showing that the hearing on the said appeal has been fixed at 11.00 a.m. on 22.12.2023 has been produced.

4. In such circumstances, the Petitioner, the Seventh Respondent and all other concerned parties shall attend the hearing on the said date as well as on the subsequent dates to which it is adjourned and extend their co-operation for the expeditious disposal of the matter and there shall be atleast two effective hearings every month showing progress of the matter. It shall be incumbent upon the First Respondent to afford full opportunity of hearing to all parties concerned following the prescribed procedure in consonance with the principles of natural justice, deal with each of the contentions raised and pass

reasoned orders on merits and in accordance with law and communicate the decision taken to them under written acknowledgment. The report of such compliance shall be filed before the Registrar (Judicial) of the Court.
