During health screening the prisoner stated that, he was suffering from Diabetes for past 8yrs under medication T.Metformin 1/2-0-1/2 and alleged H/O Lasik surgery done in B/L eyes at 2018.At present as on 6/2/23, he is able to do his day-today activities without anyone's support .His vitals are stable. His Glycemic status under control.
