ORDER

This writ petition has been filed to direct the respondents to consider and dispose of the representation dated 29/9/2022 seeking cancellation of the forged documents registered on the file of the Sub-Registrar, Thirukalukundram.

2. It is the case of the petitioner that subject property was purchased by the petitioner, on 6/5/1996. The petitioner came to know that document has been created on the basis of the Power of Attorney said to have been executed by the petitioner on 2/5/2017. Thereafter, certain mortgage deed also created, based on the said documents and sale deeds. In this regard, petitioner gave a complaint to the Police and First Information Report has been registered. At this stage, petitioner gave various representations, dated 6/1/2021, 25/3/2021, 4/8/2021 and 29/9/2022, to conduct enquiry, under Section 77 A of the Registration Act. Since the same has not been
