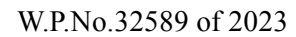

ORDER

4. The learned counsel for the writ petitioner submits that it would suffice if a direction is given to the respondents to consider the representation dated 06.12.2021.

5. The learned Special Government Pleader for respondents submits that the representation of the writ petitioner dated 06.12.2021 will be considered as expeditiously as possible.

6. Therefore, without expressing any view on the merits of the matter, this Writ Petition is disposed of with a direction to the respondents to consider the representation dated 06.12.2021, after giving due opportunity of hearing to writ petitioner as well as rival claimants / interested parties, if any and pass orders on merits and in accordance with law. Such exercise shall be done by the respondents within a period of two months from the
