ORDER

This Criminal Original Petition has been filed to modify one of the conditions imposed by the learned Principal Sessions Judge, Chennai in Crl.M.P.No.22722 of 2022 vide order dated 25.11.2022.

Learned counsel for the petitioner submitted that the petitioner was arrested and later, granted bail by the learned Principal Sessions Judge, Chennai in Crl.M.P.No.22722 of 2022 vide order dated 25.11.2022, with certain conditions. The learned trial Judge, while granting bail to the petitioner, directed the petitioner to appear before the respondent Police daily at 10.00 a.m. until further orders.
