Selection/Special Grade Scale of Pay as laid down in Schedule II of the Tamilnadu Revised Scales of Pay Rules, 1998, at 5000-8000 and 5500-9000, consequential monetary benefits and pay the arrears thereof within a time frame.

2. The grievance of the wirt petitioners is that they have not been granted Selection/Special Grade Scale of Pay as laid down in Schedule II of the Tamil Nadu Revised Scales of Pay Rules 1998. In this regard they have given representations to the respondents and the same have been considered by them. Hence, the present Writ Petition has been filed.

3. The learned counsel appearing for the respondent submitted that they have already implemented the above Government Order and if any of the petitioners are not paid, the same will be paid to them.

4. In such view of the matter, if any of the petitioners have not been paid as per Schedule II Serial No.6 of the Government order G.O.[Ms.] No.162 dated 13.04.1998, the same shall be set right and paid to the

petitioners within a period of two months from the date of receipt of a copy of this Order.
